STATEMENT OF PURPOSE AND DISCLAIMER

However, as a Not-for-Profit Organization with a charitable registration we cannot guarantee a security that goes beyond our long history. This disclosure notice is our attempt to be up front with the risk reality facing the financial community in Canada.

This offering of this Bond is not, and under no circumstances is to be construed as, a public offering. These Bonds will be issued under exemptions from the dealer registration and prospectus requirements of the Securities Act in the provinces where they are sold, which exemptions are available to Securities issued by an issuer organized exclusively for educational, benevolent, fraternal, charitable, religious or recreational purposes and not for profit, where no commission or other remuneration is paid in connection with the sale thereof. As a result, the purchaser is restricted from using most of the civil remedies available under securities laws. In addition, this Bond will be subject to certain resale restrictions under applicable securities laws in addition to the contractual restriction contained therein.
